- 2. Logo Printing, Hologram Printing, QR Code Variable Data Printing, etc. should be In-house and outsourcing of any of the mentioned items/activities will not be allowed.
- 3. Yearly Sales Turnover of the manufacturer should be Rs. 5 Crores and above in the last 2 financial years including IT solution.
- Participant should be currently serving at least 5 major clients with sales turnover of Rs. 100 Crores and above.
- 5. Participant should be a regular manufacturer of similar products for other companies.
