EOI are hereby invited from reputed engineering/fabricating companies/firms for putting up “**Bulk Non-edible Vegetable Oil Supply**”. Firms having done similar nature of work can apply along with the documentary evidence for the work done in the past. The firms should also meet the other parameters as given below and are required to submit following information along with their applications.

- 1) Name of the firm with their constitution/proprietorship/partnership detail, etc with the date of establishment/registration.
- 2) List of similar works successfully completed in the last three years as above with testimonials from department concerned and the details of contact persons.
- 3) The firm should not have incurred any loss in more than two years during the last five years ending 31st March, 2018.
- 4) List of works in hand giving nature of work, department, cost, date of start and completion with present progress and the contact details of clients.
- 5) Balance sheet of the firm for previous two years (2017-18 and 2018-19) must be enclosed with the offer certified by chartered accountant evidencing turnover.
- 6) The article of association with offer to know the standing of the firm.

Offers against this EOI should be submitted in form of E-BIDS through Central Public Procurement (CPP) Portal (<https://www.etenders.gov.in>) and only online quotations will be entertained from the registered bidders of CCP Portal. Last date of submission of EOI is **16th June, 2020 by 3.00 PM**. and shall be opened on the 17th April 2020 at 3:00 PM. Shortlisted firms shall be called for making a presentation at a later date.

If any information furnished by the applicant is found incorrect at a later stage, he shall be liable to be debarred from tendering/taking up of work in CSIR. CSIR-IIP reserves the right to verify the particulars furnished by the applicant; independently. CSIR-IIP reserves the right to reject any prospective application without assigning any reason.

Brief description of Expression of interest for bulk non-edible vegetable oil supply

CSIR-IIP is looking for a supply of non-edible oils such as a palm stearin, palm fatty acid distillates, jatropha oil, Pongamia oil, used cooking oil (UCO) or any other non-edible oil derived from plants/trees. Quantity required: minimum of 30 tons-per-month, to be supplied in barrels or tankers.

The oil required should be free from any solid contaminants, preferably prefiltered with a 400-micron filter. The desired total acid number (TAN) should not be more than 10 mg KOH/g. Those Vendors who do not know the TAN may participate in the EOI; however, in such instance, a sample of the oil must be submitted to IIP for TAN analysis.

The vendor must be able to supply the above-mentioned feedstocks either individually or in combination at the maximum possible quantity every month. Details of vegetable oil quantities available, the number of oils that will be supplied and the probable price of each oil (ex-gate) must be submitted by the vendor with the possible fluctuations in price and quantity in tabular format (for 6 months). A commitment letter will be required for continuous feed supply for 3 years from the shortlisted vendors. Only those vendors shortlisted from the EOI will be invited for tendering.
