INSTRUCTIONS FOR ONLINE BID SUBMISSION

CSIR-Indian Institute of Petroleum is a constituent establishment of CSIR located in Dehradun, is engaged in the Research & Development activities. Being one of the major laboratories of CSIR chain of laboratories, CSIR-IIP required gases from the manufacturer or through authorized dealer network.

As a policy decision, it has now been decided to enter into an Annual Rate Contract for supply of the following Gases for our R&D use:-

You are, therefore, requested to offer your products range with rates on your company letter Head and in the printed form by respective manufacturer. The annual Rate Contract so concluded will have to take care of the following conditions:

1. The tender form/bid documents may be downloaded from the web site:

- 2. Bids must be mandatorily submitted Online through Central Public Procurement Portal https://etenders.gov.in/eprocure/app
- 3. Bids are invited in Single Bid System.
- 4. Manual/Offline bids shall not be accepted underany circumstances.
- 5. Tenderers/bidders are requested to regularly visit the website: <u>https://etenders.gov.in/eprocure/app</u>. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
- 6. In case, the day of bid opening is declared a holiday by the government, the tenders will be opened on the next working day at the same time. No separate intimation shall be sent to the bidders in this regard.
- 7. <u>The companies which cannot provide validity of rates for One Year need not apply.</u>
- 8. The firms should be clearly mentioned their GST number.
- 9. The Rate Contract will generally be valid for a minimum period of one year, however RC can be extended for a limited period on mutually agreement.
- 10. There will be no change in price structure during the currency of contract except of the statutory levies which are made applicable by the Govt. through notifications/regulations change.
- 11. <u>The current Authorization/Dealership letter of principal company is to be attached</u> <u>along with tender.</u>
- 12. Price Must be quoted on the basis of Discount on Net Dealer Price(NDP) for each category of items in terms of Percentage (%) discount on NDP. Additional Dealer Discount may also be mentioned clearly as and when applicable.
- 13. All gas cylinders should have colour code.
- 14. All UHP gas cylinders should be supplied with purity certificate as well as label.
- 15. Purity standards should be followed and complied with in respect of all supplied gases. The purity standard for UHP grade gases should not be less than 99.999%. Further, purity standard in respect of supply of gases like Oxygen and Dissolved Acetylene should not be less than 99.9%.
- 16. If in cases supplier will not be follow the purity standard then Rate contact will be terminated with immediate effect.
- 17. All gases supplied should have a capacity of 47 Lit (7Cu Mts.).
- 18. No security deposit will be given for gas cylinders.
- 19. All filled up cylinders should be delivered by the supplier to CSIR-IIP by his own vehicle and he will bear the cost. Further Supplier should also take the empty cylinders from CSIR-IIP through his own vehicle and in this case also he will bear the cost of transportation.
- 20. Rental charge of gas cylinders will be paid only after the expiry for rent free period.
- 21. If Supplier failed to supply the gases within the currency of rate contact period then the rate contract will be terminated with immediate effect.
- 22. Price should be FOR delivery at Stores CSIR-IIP, Mokhampur, Dehradun, Uttarakhand.
- 23. Prices charged for the stores supplied under Rate Contract should under no event be higher than lowest prices at which the principal company/authorized dealer sells the items of identical description to any other Govt. organization during the period of

contract failing which the "FALL CLAUSE" of CSIR rules will be applicable. A certificate to this effect may be provided by the principle company/authorized dealer that the lowest prices have been offered to CSIR-IIP failing which the offer will not be considered. In case it is found that the prices charged by the firm are higher, the same will be recovered from the subsequent/unpaid bill of the supplier.

- 24. Please also confirm whether the offered items are available on GeM. In case the same are available in GeM the rate contract proposal will not be concluded & purchases of such items shall be made through GeM only.
- 25. In terms of GOI order No. P-45021/2/2017-PP/BE-II dated 04.06.2020 and 16/9/2020 regarding Preference to make in India Products : -
 - Class-I Local Supplier-Whose Goods offered for procurement has local content equal to or more than 50% as defined below:
 - (ii) Class II Local Supplier- Whose goods offered for procurement has local content more than 20% but less than 50% as defined below:

Local Content: Means the amount of value added in india, which shall, unless otherwise prescribed by Nodel Ministry, be the total value of item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all custom duties) as a proportion of the tatal value, in percent.

-A self certified copy mentioning the percentage of local content in compliance of this provision may be attached along with the bid.

- 26. The stores shall be supplied immediately within a period of 15 days either directly or through authorized distributor/dealer, otherwise CSIR-IIP reserve rights not to accept delivery in part or full to claim late delivery penalty at 0.5 % per week subjected to a maximum of 10% of total value of purchase order from the vendor for non-compliance of the ARC terms and conditions
- 27. CSIR-IIP, Dehradun reserves the right to enter into parallel Rate Contract for similar items during the period of Rate Contract with one or more parties.
- 28. Termination of Rate Contract The rate contract can be terminated at anytime without assigning any reasons by giving one month notice. Conditional.
- 29. If the supplier fails to deliver the material within the delivery period as specified, purchaser may procure such items as deems appropriate for.
- 30. The supplier will be liable to the purchaser for any excess costs incurred for procurement of goods or services not delivered in time.
- 31. Discount, taxes and other levies if any are to be specified clearly in the bid.
- 32. Vague terms like "packing forwarding transportation etc. extra" without mentioning the specific amount/percentage of these charges will not be accepted. Such offer shall be treated as incomplete and rejected.
- 33. The final acceptance/decision on the rate contract will be taken after screening the offers by a duly constituted committee and the Director reserves the right to accept/reject the

tender wholly or partially without assigning any reasons thereof.

- 34. This Institute is exempted from payment of customs duty in terms of Government Notification No.51/96-Customs and Central Excise duty exemption in terms of Notification No.43/2017-Central Excise valid from 30.06.2017. Actual User condition (Non-Industrial-R&D Institution). GST will be paid as per Notification No.47/2017-Integrated Tax (Rate) Dated 14th November 2017 issued by Ministry of Finance, Department of Revenue, Govt. of India. However, prevailing rates of GST may be mentioned separately. No other charges other than those mentioned clearly in the quotation will be paid.
- 35. Rate Contract offer should be quoted/submitted by manufacturers/ The authorized distributor/dealer alongwith Bid Submission Format.
- 36. The manufacturer should either have at least previous RC with CSIR-IIP or should have at least 5(five) RC with CSIR labs/ICMR/ICAR/IIT/Central Universities/DRDO. The tenderers should enclose the copies of Rate Contract of CSIR/ICMR/ICAR/IIT/Central Universities/DRDO institutes for the past five years to whom they have supplied/entered into Rate Contract the same/similar nature of items (with complete address, telephone/fax no. and contact person). However Competent Authority may consider the offer of reputed manufacturer keeping in the view of requirement of the institute.
- 37. All disputes will be subject to Dehradun jurisdiction.
- 38. The tenders are also liable to be rejected if the above conditions are not complied with.
