

इस कार्यालय की समसंख्यक अधिसूचनाओं दिनांक 17 अगस्त, 2021 जिनके माध्यम से सुरक्षा अधिकारी के पद हेतु "शारीरिक और व्यक्तित्व मूल्यांकन परीक्षण" के लिए योग्य पाए गए 35 अभ्यर्थियों तथा अयोग्य पाये गए 74 अभ्यर्थियों की सूची अधिसूचित की गई थी, के अनुसरण में उन अभ्यर्थियों के आवेदन जो अधिकतम आयु के कारण निरस्त किए गए थे, भूतपूर्व सैनिकों की भर्ती हेतु वर्तमान नियमों के तहत पुनः जाँचे गए। तदनुसार, सुरक्षा अधिकारी के पद हेतु "शारीरिक और व्यक्तित्व मूल्यांकन परीक्षण" के लिए योग्य पाए गए 56 अभ्यर्थियों तथा अयोग्य पाये गए 53 अभ्यर्थियों की संशोधित सूची अधिसूचित की जा रही है।

In continuation to this office Notifications of even No. dated August 17, 2021 according to which lists of 35 shortlisted candidates and a list of 74 candidates not found eligible for "Physical & Personality Assessment Test" for the post of Security Officer were notified, the eligibility of the candidates rejected on the ground of OVERAGE were re-examined on the basis of extant rules for recruitment of Ex-servicemen. Accordingly, the revised lists of shortlisted candidates eligible for "Physical & Personality Assessment Test" and list of rejected candidates for Security Officer post are being notified for information of all concerned as under:

Screening Criteria: (i) Ex-Servicemen JCO (Subedar or higher rank) <u>OR</u> equivalent rank in other para-military forces with minimum of 10 years experience in security. However, number of years of experiences shall be 05 years in case of Short Service Commissioned Officers and incumbents holding the positions of Assistant Commandant in CRPF/BSF/ITBP etc. carrying the pay scale of Rs. 8000-13500 (pre-revised). In the case of Inspector from Para Military Forces, the number of years of experience required shall be 10 years.

(ii) The upper age limit is relaxed by the length of military service increased by three years in the case of exservicemen eligible for the post as per Ministry of Personnel, Public Grievances and Pensions, DoPT, Govt. of India, Office Memorandum No. 36034/3/2013-Estt (Res) dated 25th February, 2014.

5. Relaxation regarding age limit

For appointment to vacancies in Group B (Non-Gazetted), Group C or Group D posts in Central Government, an ex-servicemen shall be allowed to deduct the period of actual military service from his actual age and if the resultant age does not exceed the maximum age limit prescribed for the post for which he is seeking appointment by more than three years, he shall be deemed to satisfy the condition regarding age limit.

For appointment to any vacancy in Group A and Group B services or posts filled by direct recruitment otherwise than on the results of an Open All India Competitive Examination, the upper age limit shall be relaxed by the length of military service increased by three years in the case of ex-servicemen and commissioned officers including Emergency Commissioned Officers of Short Service Commissioned Officers.

For appointment to any vacancy in Group A and Group B services or posts filled by direct recruitment on the results of an All India Competitive Examination, the ex-serviceman and Commissioned Officers including Emergency Commissioned Officers or Short Service Commissioned Officers who have rendered at least five years military services and have been released—

- On completion of assignment (including those whose assignment is due to be completed within one year) otherwise than by way of dismissal or discharge on account of misconduct or inefficiency; or
- On account of physical disability attributable to military service or on invalidment shall be allowed maximum relaxation of five years in the upper age limit.

The expression 'direct recruitment on the results of an All India Competitive Examination' means (i) all recruitment by UPSC whether through written examination or by interview or both; and (ii) recruitment made by other authorities including Staff Selection Commission or any other appointment authority through written competitive examination or test (but not by interview only). The expression 'direct recruitment otherwise than by open competition' means (i) any recruitment not made by the UPSC or (ii) recruitment not made through written competitive tests held by any other authority.
