



Advt. No. 04/2022 : Engagement of Part Time Lady Doctor

The Director, CSIR-Indian Institute of Petroleum, Dehradun desires to engage one Part Time Lady Doctor [General Physican-Allopathy System] on purely temporary basis for providing medical facilities to the employees/pensioners and their family members and research scholars of CSIR-IIP, Dehradun. The eligibility criterion is as follows:-


Position	Part Time Lady Doctor (General Physician-Allopathic system)
No. of Positions:	One
Maximum Age Limit	60 Years. (as on the date of walk-in-interview)
Consolidated Honorarium	Selected candidate will be paid a consolidated honorarium of Rs. 32,670/- (Thirty-Two Thousand Six Hundred Seventy Only) per month for performing 03 hours duty per days on all days (except Sunday and holidays).
Essential Qualification	MBBS Degree with minimum 55% marks with valid registration in Uttarakhand Medical Council.
Desirable Qualification	Two years working experience in a well established Hospital/Nursing Home and/or MD (Medicine)
Job Requirement	To attend outpatients at CSIR-IIP Dispensary for 3 hours per day on all working days at mutually agreed time (except Sundays & Holidays). Working hours will be as per our dispensary timings as under: Morning: 8:00 AM to 12:30 PM Evening: 4 PM to 6 PM Saturday (8:00 to 10:00 AM)
Period of engagement	Part Time Doctor will be on purely temporary basis initially for a period of Six Months extendable for another six months or regular appointment of Medical Officer, whichever is earlier. However, it will not be extended after attainment of 60 years of age in any circumstances.
Procedure for Selection	The Part Time Lady Doctor will be selected on the basis of performance in interview.
Date, Time and Venue of Walk-in-Interview	November 22, 2022(Tuesday) at 9:00 AM at CSIR-IIP, Dehradun. (The candidates are expected to report by 9:00 AM at the Institute reception. No candidates would be allowed for walk-in-interview after 10 AM.

General terms & conditions for engaging Part Time Doctor:

- (1) The candidate must be a Citizen of India.
- (2) The date for determining age/qualification and experience shall be the date of walk-in-interview
- (3) No TA/DA will be paid for attending the interview or for joining of the position.
- (4) The above position is purely on temporary basis. Candidates engaged will not confer any right implicit or explicit for consideration of regularization/absorption against any CSIR/IIP regular post(s).
- (5) **Leave:** The part time doctor will not be entitled for any kind of regular leave. However, they would be entitled to 8 days leave in a calendar year, to be calculated on pro-rata basis.
- (6) **Termination of Service:** The engagement may be terminated at any time by the office without assigning any reason by giving a notice of 30 days. In case, a part time doctor desires to leave the assignment, he/she has to serve the notice before 30 days.
- (7) The selected candidate, is expected to join within a week from the date of receiving the offer of engagement after completion of pre-engagement formalities.
- (8) CSIR-IIP reserves the right to cancel or withdraw the award in case of any discrepancy found at any state of selection.
- (9) The Director, CSIR-IIP reserves the right to not to fill the position.
