(ii) Others who do not fall under (i) above will get monthly stipend Rs. 25000 and HRA as per rules.

<u>Mode of Selection</u>: Selection is to be done on the basis of Interview; however, written examination may be conducted for screening, if required. Syllabus of the written examination would be from the concerned subject.

How to apply:

Eligible and interested candidates are required to appear at CSIR-Indian Institute of Petroleum, Mohkampur, Haridwar Road, Dehradun for walk-in-interview on the above mentioned stipulated date and time alongwith duly filled-in application form given with the advertisment, supported by one set of self attested copies of certificates regarding (i) Educational Qualification, (ii) Age, (iii) Category (in case of SC/ST/OBC/PWD candidates), (iv) One latest passport size photograph, (v) Experience certificate, if any; and (vi) detailed biodata etc. Original certificates are required for verification, which would be returned immediately on the same day after verification.

General Terms & Conditions:

1. Engagement will initially be for a period of six months/one year depending upon the project requirement, which may be extended or curtailed depending on the duration of the project/desired level performance or conduct of the incumbent, as the case may be.

Tenure of engagement of the Project Staff shall be co-terminus with the project. However, under no
circumstances the tenure would be allowed to exceed five years duration taken into consideration engagement
in all CSIR Labs. The performance of the Project Staff would be reviewed periodically so that any one not found
up to the mark, could be terminated without assigning any reason.

3. All these positions are temporary and are on behalf of the sponsors and, therefore, does not confer any right on

the incumbent to any claim, implicit or explicit for absorption on any post in CSIR-IIP/CSIR.

4. Candidates have option to reply in Hindi during the interview.

5. On completion of the tenure in one project, in case, one wants to apply for engagement in another project, he/she will have to go through the process of selection by submitting a fresh application under the new project. Engagement of the Project Staff under the new project would be made only after submission of resignation and "No Demand Certificate" in the previous project.

3. Houre Rent Allowance (HRA) will be paid as per rules and only if there is provision of HRA in the concerned project. If accommodation is provided, licence fee, water and electricity charges would be deducted as per CSIR

rules.

7. The Project Staff shall be permitted to avail leave as per rules.

8. Experience, where required, will be calculated from the date of acquiring minimum educational qualification.

9. Final semester and result awaited candidates are not eligible for above mentioned positions.

10. For the positions where Ph.D. is essential qualification only Ph.D. awarded candidates may apply. Ph.D. (submitted) are not eligible.

11. TA/DA will not be paid for appearing in walk-in-interivew or for reporting to duty after selection.

12. Number of positions may vary depending upon the Project requirements at the time of Walk-in-Interview for upcoming projects.

13. The panel of Project Staff may be prepared for future requirements, if any.

14. The candidates are advised to make their own arrangements for stay for an extra day.

15. The Director, CSIR-IIP reserves the right to not to fill any or all advertised posts.

16. Canvassing in any form will be treated as disqualification for the positions.
